EFRAH- Empowerment for Rehabilitation Academic & Health is a NGO came in legal existence on 17th March 1999 and registered in Delhi (India) as well as registered under FCRA, registration No. 231660324. We started with 150 children of vegetable vendors in Okhla vegetable market area, New Delhi with an aim to mitigate child labor and mainstream those children with school for the sake of availing regular education. Those 150 children were engaged as child labor along with their parents in vegetable market. The core area of EFRAH intervention is **Education** (Facilitating children through learning centers & Vocational Training centers, mainstreaming those children with school, Advocating Right to Education Act implementation and importance of social & financial education), **Livelihood** (Self Help Group formation, Micro Finance & placement of students capacitated through vocational training), **Health** (RCH Awareness & HIV/AIDS prevention among female sex workers and migrant labors) and **Awareness** (Advocacy for Child Rights, domestic violence and sexual harassment related to Adolescent girls/Women). At present, We are working in Madanpur Khadar J.J. Colony, Ali Vihar, Okhla industrial area, Sangam Vihar, Tughlakabad Extension, jamia nagar and MCD schools of central Zone of Delhi and Noida (U.P.). EFRAH has been closely working with Delhi Government on Gender, Education and Health related issues.
